- 1. Complete this Daycare Application/Agreement
- 2. Meet our vaccination and temperament standards (must be up to date on Rabies, Distemper, and Bordetella shots. We also recommend the Canine Influenza vaccine, but it is not required. We will also allow a titres test in place of vaccination records.)
- 3. Be spayed or neutered.
- 4. Dogs must be over 6 months to attend daycare.

## Barks on Bourbon Daycare Terms and Conditions

## \*\*\* Please Read and Initial Each Section \*\*\*

# Emergency Medical Care: If, in our judgment, your dog requires immediate medical care and we are unable to reach you, we will take your dog to a veterinarian or animal

## hospital.

To ensure the health and safety of your dog and all other guests, we require that all of our clients agree and comply with the following terms and conditions:

#### Initials

\_\_\_\_\_\_ I specifically represent to Barks on Bourbon that I am the legal owner of my dog. In addition, my dog is healthy, my dog meets Barks on Bourbon's vaccination standards, my dog has not harmed or shown aggression or threatening behavior towards any person(s) or other dog(s) and has not been exposed to any known communicable disease within the 30 day period immediately prior to admission to day care. I further represent that each time my dog is brought to Barks on Bourbon, I will be recertifying that my dog is in good health and has not had any communicable illness of any kind for 30 days prior to admission. I further agree to inform Barks on Bourbon of any changes in my dog's condition and/or behavior prior to any day care visit.

\_\_\_\_\_ I understand that my dog must be spayed or neutered prior to attending day care (6 months of age or older). In addition, I am not permitted to bring personal items to day care.

\_\_\_\_\_ I understand day care is offered between 7 A.M. – 6 P.M. Dogs who are not picked up by closing time (6 P.M.) will be charged \$10.00 for every 15 minutes after 6 P.M.

\_\_\_\_\_\_ I understand that my dog is required to be fully vaccinated (including distemper, rabies and bordetella) and I will provide Barks on Bourbon with proof thereof from my veterinarian. I agree to provide Barks on Bourbon with annual updates of my dog's vaccination records. I acknowledge that it is my responsibility to ensure that my dog continues to be fully vaccinated and that Barks on Bourbon reserves the right to remove my dog from the facility if it is not fully vaccinated.

\_\_\_\_\_ If your dog is exhibiting any symptoms that may suggest illness such as sneezing, coughing, wheezing, runny eyes or nose, vomiting, lethargy, or diarrhea, please do not bring your dog for daycare, boarding, or grooming services.

\_\_\_\_\_\_ I understand that my dog must have flea protection in the form of a topical liquid such as K9 Advantix, Advantage, Frontline, or a flea collar. I understand that my dog will be inspected for fleas when entering Barks on Bourbon, and will be refused entrance if fleas are found. I further acknowledge that Barks on Bourbon shall not be held responsible if my dog contracts fleas while at Barks on Bourbon because proper flea protection is my responsibility.

\_\_\_\_\_\_ I understand that the leash-free environment at Barks on Bourbon provides dogs the opportunity to play in close physical contact, including with their teeth and paws. I acknowledge that no amount of supervision or personalized care by Barks on Bourbon, its agents or employees, can prevent the possibility of injury or illness to my dog.

\_\_\_\_\_\_ I understand that day care at Barks on Bourbon is a cage-free service. I accept the risks involved and agree that I am solely responsible for any damages that result from injuries caused to my dog while at Barks on Bourbon. I agree to indemnify and hold harmless Barks on Bourbon from any and all claims, liabilities, costs and expenses, including court costs and attorney fees, arising out of any harm or injury caused by, or to my dog to other dogs or persons. I authorize Barks on Bourbon to do whatever is deemed necessary for the safety, health and well-being of my dog and I agree to assume full financial responsibility for any and all medical expenses incurred. I expressively waive and relinquish any and all claims against Barks on Bourbon, its employees, agents, and representatives for any injury, illness, or harm to my dog. Under no circumstances will Barks on Bourbon be liable for consequential damages or damages beyond the replacement value of my dog.

\_\_\_\_\_\_ I understand Barks on Bourbon reserves the right to refuse admittance to any dog that displays signs of untreated or potentially contagious conditions, demonstrates aggressive behavior, or who fails our standard health and temperament policies. I further understand and agree that any problems that develop with my dog will be treated as deemed appropriate by the staff of Barks on Bourbon, in their sole discretion.

\_\_\_\_\_ In the event any provision of this agreement is declared by a court of competent jurisdiction to be unenforceable, the remaining provisions shall remain in full force and effect.

\_\_\_\_\_ No choke chains, corrective collars, harnesses, or clothing of any type allowed in daycare.

\_\_\_\_\_ All charges must be paid in full upon pick-up of your dog. Dogs left ten days beyond the agreed pick-up date will become property of Barks on Bourbon and may be disposed of at the kennel's discretion.

\_\_\_\_\_\_ We accept Visa, Mastercard, Discover, or cash. Payment is due upon pick-up of your dog. Barks on Bourbon reserves the right, without notice, to adjust its fees for services. Please inquire at the front desk as to our current fees.

By submitting this form,

- 1. \_\_\_\_\_ You indicate your agreement with all the terms listed hereof,
- 2. \_\_\_\_\_You release, indemnify, and agree to hold Barks on Bourbon harmless from any and all manner of damages, claims, loss, liabilities, costs or expenses, causes of actions or suits, whatsoever in law or equity, (including, without limitation, attorney's fees and related costs) arising out of or related to the services provided by Barks on Bourbon, except which may arise from the sole gross negligence or intentional and willful misconduct of Barks on Bourbon, including, without limitation, (i) any inaccuracy in any statement made by yourself for information provided by you to Barks on Bourbon, (ii) your dog, including but not limited to destruction of property, dog bites, injury, and transmission of disease, and (iii) any action by yourself which is breach of the terms and conditions of this agreement.

3. \_\_\_\_\_ This agreement covers the current relationship between Barks on Bourbon and yourself. Each time you bring your dog to Barks on Bourbon, you affirm the terms of this Agreement, and the truthfulness and accuracy of all statements you make in this Agreement.
