_____ I acknowledge and understand that there are certain risks involved in daycare and boarding, including but not limited to dog fights, dog bites to humans or other dogs, and the transmission of disease. Any medical expenses will be my responsibility and I release Barks on Bourbon of any charges.

_____ All dogs must be healthy and current on all vaccinations. You will be required to bring a copy of your dog's updated vaccination records from your veterinarian before you start daycare or board with us to ensure your dog's safety as well as that of our existing Barks on Bourbon dogs.

_____ If your dog is exhibiting any symptoms that may suggest illness such as sneezing, coughing, wheezing, runny eyes or nose, vomiting, lethargy, or diarrhea, please do not bring your dog for daycare, boarding, or grooming services.

_____ No choke chains, corrective collars, harnesses, or clothing of any type allowed in daycare.

_____ All charges must be paid in full upon pick-up of your dog. Dogs left ten days beyond the agreed pick-up date will become property of Barks on Bourbon and may be disposed of at the kennel's discretion.

_____ We accept Visa, Mastercard, Discover, or cash. Payment is due upon pick-up of your dog. Barks on Bourbon reserves the right, without notice, to adjust its fees for services. Please inquire at the front desk as to our current fees.
